- Truck driver (ANZSCO 733111).

These occupations has a level of skill commensurate with the qualifications and experience outlined on the government website.

Requirements

- Must have completed the construction safety training;
- Experience in construction industry;
- Physically fit;
- Being able to perform manual tasks;
- Relevant qualification
- International applicants must have enough financial means to cover living expenses for a duration of one year.

Remuneration package

This is an ongoing casual position. The remuneration package includes \$29.00 per hour before tax (\$55,680 annual) salary plus superannuation with the opportunity to become a permanent employment. Sponsorship is also provided for international applicant as part of the visa processing.

Sponsorship procedure (for international applicants only)

The Institute of Construction Materials offers sponsorship to international construction workers as part of their visa application process with the Department of Home Affairs. We are offering sponsorship for temporary workers based on the conditions outlined by the Australian Department of Home Affairs for [Temporary Skill Shortage Visa \(subclass 482\)](#). The current construction jobs may vary depending on the project. However, most of the projects require skilled concreters, bricklayers, painters, excavators, steel workers, scaffolders, cabinet makers, and so on. You must have received a sponsorship offer from our human resources team before being considered eligible for the current employment opportunities.

Step-by-step sponsorship process:

1. Apply for the [Construction Worker](#) job position;
2. Receive the official letter of sponsorship offer from our human resources team. This is a unique document in a PDF format sent to your email address;
3. Pay the sponsorship fee using the link provided below;
4. Receive the offer of employment;
5. Apply for [Temporary Skill Shortage visa \(subclass 482\)](#). If you want us to purchase your health insurance cover on your behalf, please visit [Overseas Workers Health Cover](#) page.
6. Once your visa is granted, you may refer to [accommodation for overseas workers](#) to sort out your rental property in Sydney. There are plenty of rental properties available in Sydney. You may be required to pay additional fees if you want the Institute to rent a property on your behalf.
7. Arrive in Australia and start your job.

There's a 10% discount on sponsorship fees for applicant who successfully obtain their language proficiency certificate with the required results as followed:

Test	Required results
International English Language Testing System (IELTS)	Overall band score of at least 5.0 with a score of at least 4.5 in each of the test components.
Occupational English Test (OET)	Score of at least 'B' in each of the four components
Test of English as a Foreign Language internet-based Test (TOEFL iBT)	iBT total score of at least 35 with a score of at least 3 for each of the test components of listening and reading, and a score of at least 12 for each of the test components of speaking and writing
Pearson Test of English Academic (PTE Academic)	Academic overall test score of at least 36 with a score of at least 30 in each of the test components
Cambridge C1 Advanced test	Overall test score of at least 154 with a score of at least 147 in each of the test components.
